Sir,

With reference to the subject and letter cited above, I am to inform that the information submitted by the State Govt letter under reference (i) above has been examined in this office but found incomplete. The offence letter dated 23.10.2022 drawn by the Range Officer, Tafragam Forest Range under Lohit Forest Division mentioned that "Illegal establishment of stone crusher, site camp collection of RBM and construction of temporary approach road at Samsonghrt, Demwe under Tafragam ARF".

In view of the above. State Govt is requested to furnish the detail action taken report under section 3A and 3B of F(C) Act, 1980 mentioning the date of commencement of work and extent of work already done in the proposed area without prior approval of Central Govt. Further, the corrected shape/kml file of the proposed area is to be furnished as the submitted shape file is incorrect and found to be 0.447 ha instead of 0.687 ha.

State Govt. is requested to kindly furnish the above information to this office for further processing of this proposal.
