

महोदय,

उपरोक्त सन्दर्भित पत्र का आशय ग्रहण करते हुए मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरांत निम्नलिखित कमियां पाई गयी हैं:

1. Brief profile of the leases giving details of their existing mining lease in the state with their capacity of production, the present level of average annual production, location of there pits and the status of reclamation of forest land that are exhausted minerals may be provided to this office.
2. State Govt. may provide the details of all other mining leases for the same mineral with their capacity and average annual production and projected future requirements to this office.
3. The state govt. may submit the revised maps i.e. digital map/Sol toposheet and KML map in which safety zone area of 7.5 m wide peripheral within the mining lease marked and submit to this office and also upload the same in the online portal.
4. The State Govt. may show the safety zone area in component wise breakup at para B 2.4 online.
5. The State Govt. may submit the plantation scheme for one and a half times of safety zone area in any degraded forest land.
6. State Govt. may submit the undertaking to this regard that the width of 10 m & 50 m strip on either side of public roads and natural streams respectively located inside the mining lease shall be protected but will not be considered as a part of safety zone area.
7. State Govt. may submit the NoC of village 'Pashada' to this office.
8. State Govt. may submit the FRA certificate with all its annexures to this office.
9. State Govt. may review & revise the KML of the diversion area as instead of 2.1532 ha in the DSS analysis the area calculated as 1.64 ha only. The KML may be revise in view of point 3 above.
