Madam,

With reference to the subject and reference cited above, it is to inform that the proposal has been examined and the following additional information/ clarifications are required for further processing of the proposal. It is requested to submit following additional information / clarification / documents for further consideration of the proposal:

- a. As the proposed diversion area is falling in the Tiger Corridor of Kawal Tiger Reserve, approval of the SC NBWL may be obtained and submitted.
- b. The User Agency and the FDO uploaded kml file of the non-forest area for an extent of 2.9929 ha. However, CA scheme has been proposed for an area of 2.1948 ha. Hence, correct kml file and CA scheme specific to the current proposal may be uploaded.
- c. Though 81.4313 ha Non-Forest Land has been identified in lieu of 21 road projects, the detailed list of 21 proposals with apportioned extent of each such proposal, its map and DGPS co-ordinates of the entire 81.4313 ha is not submitted. Map along with DGPS co-ordinate of the entire 71.00 ha of Degraded Forest Land identified for CA purpose may also be submitted.
- d. FDO reported in the SIR that "the present road existing with width of 5.5 meters which is metal road". Hence legal status of the existing road needs to be submitted by the State government.
- Site inspection report and Part-II filled by the DFO concerned may be uploaded in place of the report of FDO.
- f. Component wise breakup of the proposed road clearly indicating carriage way (BT portion), shoulders, drainage etc needs to be provided by the user agency.

- g. As per the kml file, either side of the proposed road, agriculture fields are seen. Hence the legal status of the proposed area for diversion indicating any encroachment/ RoFR holdings may be furnished.
- h. Status of the villages (Kammargaon and Nandigaon) notified revenue villages/ Forest Villages/ encroachments may be intimated along with supporting documents.
