A copy of the reference 7th cited is enclosed herewith, wherein the Integrated Regional Office, MoEF&CC, GoI, Hyderabad has called for certain additional information on the subject proposal for further consideration of the proposal.

The IRO, MoEF&CC, Gol, Hyderabad has informed that the proposed alignment is deviating from the existing road and is cutting across the forest area leaving a small fragment / patch of forest, which is prone to encroachment in future. In view of the said fact, it was requested to follow the existing road alignment instead of diverting from the existing road. The proposed alignment, if approved will leave about 2-3 Ha of FL making it vulnerable to encroachment. Further, if the road is aligned along the existing road and the outer boundary of forest, the road may act as a permanent boundary to the forest area. Therefore, the proposed road may be aligned along the existing road and the outer boundary of notified forest before it joins the private land and requested to submit revised alignment of proposed road for further processing and consideration.

In view of the above, the Executive Engineer, R&B Division Kamareddy District is requested to submit DGPS raw-data for the revised alignment as suggested by the IRO, MoEF&CC, Gol, Hyderabad and submit the same to this office for verification and authentication. The DGPS survey is to be conducted in the presence of the staff of District Forest Officer, Kamareddy.

The Executive Engineer, R&B Division Kamareddy District is requested to ensure that

no work is taken up in violation of the Forest and Wildlife Act in the forest area in question, before obtaining forest clearance. If any work in violation is carried out, the concerned will be held responsible and necessary action as per the rules and guidelines in vogue will be taken up.
