With reference to the subject and letter cited above, I am to inform that State Govt letter under reference (i) above has been examined in this office and observed the following lacking information:-

1. The State Govt to submit the consent of NBWL as the aerial distance of the proposed area "DGR" is 3.1 Km from deemed Eco-Sensitive Zone of Dehing Patkai National Park.
2. The identified CA site is to be inspected by an officer not below the rank of Conservator of Forest and report to be submitted mentioning vegetation and forest cover density along with their photographs taken on the site or else, an alternate CA site is to be submitted along with SOI maps, site suitability certificate, GPS-coordinates, shape file etc.

State Govt. is requested to kindly furnish the above information to this office for further processing of this proposal.
