- (ii) Regional Office shall also submit its report on compliance of the conditions imposed by MOEF and CC in the approval granted to the same user agency for Parsa East and Kete Basan captive coal block open cast mining project in favour of M/s Rajasthan Rajya Vidut Utpadan Nigam Limited in South Surguja Forest Division in Surguja District of Chhattişgarh. vide this Ministry's letter no. F. No. 8-31/2010 dated 15.03.2012.
- (iii)State government shall submit complete compliance of the conditions imposed by MOEF and CC in the approval granted to the same user agency for Parsa East and Kete Basan captive coal block open cast mining project in favour of M/s Rajasthan Rajya Vidut Utpadan Nigam Limited in South Surguja Forest Division in Surguja District of Chhattisgarh vide this Ministry's letter no. F. No. 8-31/2010 dated 15.03.2012.

In view of the above, the State Government is requested to submit information/document for the point (iii) above to this Ministry for further necessary action in the matter.
