उपर्युक्त प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव में निम्नलिखित त्रुटियाँ पाई गयी। राज्य सरकार निम्नलिखित बिन्दुओं पर आवश्यक सूचनायें प्रेषित करने का कष्ट करें, ताकि अग्रिम कार्यवाही सुनिश्चित की जा सके:--

- 1- The villages proposed to be connected by the proposed road have scattered households. The proposed alignment with a width of 9m tries to connect each and every household rather than provide connectivity to the village. Further, there is an existing road on the western side of the village proposed to be benefitted. Hence, the State Government is requested to comment on the feasibility of connecting the proposed village with the existing road on the western side.
- 2- Considering the scattered nature of the population which the proposed route intents to connect the width of the proposed route may be restricted to 7m. The tree enumeration details for the 7m width shall be submitted.
- 3- NPV is calculated at older rates. State Govt. is requested to submit/ upload NPV calculation sheet as per the latest rates.
- 4- The proposed CA area of 7.75 ha contains 6.0 ha MDF which is not suitable for planting trees @ 1000 trees per hectare. The State Govt. is requested to either replace this area with other suitable area for raising CA @ 1000 tree per hectare or provide any suitable degraded forest land for planting 6000 balance number of plants with all requisite details.
- 5- The State Govt. is requested to review the CA scheme again and submit it as per the rate prevailing in the State of Uttarakhand.
- 6- This project is within Eco-Sensitive Zone of the Askot Wildlife Sanctuary. Therefore, the comments of Chief Wildlife Warden are required about applicability of Wildlife Clearance along with requirement of animal passage plan, if any.
- 7- The proposal involves 0.5 ha area for muck dumping. Therefore, the State Govt. is requested to submit the separate enumeration list of trees lying in this area.

8- The villages to be connected are not clearly shown with labels on the KML. The State Govt. is requested to clearly mark the locations of concern villages in the KML uploaded in online portal.
