Sir,

An indent/application having proposal No. FP/JK/Road/148576/2021 has been received from your department on PARIVESH portal for diversion of 0.43 Ha of forest land for construction of link road from Shangroo to Nagni Gujjar Basti in Bhaderwah Forest Division by PWD in Bhaderwah Forest Division. In this road 0.43 Ha of forest land and 39 trees/saplings of Dedar and Kail are involved.

A Resolution from Halqa Panchayat Sangroo Ward No. 2 has been received by DFO Bhaderwah (copy enclosed) citing that there is no need of this road for the villages of Shangroo and Gujjar Basti, as both the villages have been connected with two roads namely Trown and Khumari. DFO Bhaderwah has furnished his report vide No. DFO/Bhad/FCA/3015-19 dated 09-0-9-2022 (copy enclosed).

In view of the above, it is requested to furnish your comments in the matter so that further appropriate action can be taken with regard to forest clearance of the proposal.

Sub:- Use of 0.43 ha of forest land for the construction of Link road from Shangroo to Nagni Gujar Basti in Bhadarwah Forest Division.

Sir,

With reference to the subject cited above, it is to inform you that this office has received a resolution from Halqa Panchayat Shangroo Ward No. 2 (Copy Enclosed) stated that we the inhabitants of villagers Shangroo and Gujar Basti wants to bring some few points in your kind notice regarding the construction of the above said road:-

1. That the above said road passes between the villages and in the private land of the land owners of these two villages.
2. That this road will benefit only one house.
3. That there is no need of this road for the villages of Shangroo and Gujar Basti.
4. That this road passes between the closure of Forest Department.
5. That by the construction of this road there is a huge damage to the closure as well as Forest crops.
6. That the two villages has already connected with two roads.
 - (i) Trown road which is behind the villages.
 - (ii) Khumari road which is in front of the villages.
 - (iii) Both the two road are open for traffic movement.
7. That by the construction of this road there is no benefit to the people of these two villagers.

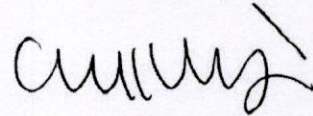
In this connection, this office forwarded the resolution to Range Officer Keller Range vide this office No. DFO/Bhad/2457 dated 04-08-2022 for on spot verification and report to this office for onwards submission to higher authority for forest clearance.

Accordingly, the Range Officer Keller Range vide his No. RO/238/K dated 31-08-2022, submitted his report after proper verification sought from villagers:-

- a) That the people of village Nagni as well as Shangroo are against the construction of the said road because the said road will benefit only one house.
- b) That by the construction of this road, 0.43 ha of forest land is involved in the construction of the said road, that two will pass through middle of a closure in Comptt. 60/K.
- c) That as claimed by the general masses, even the nomenclature of the said road is incorrect, therefore the people exhorted the said road should never be constructed at any cost.

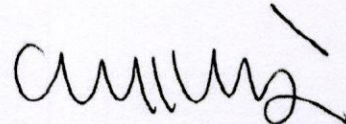

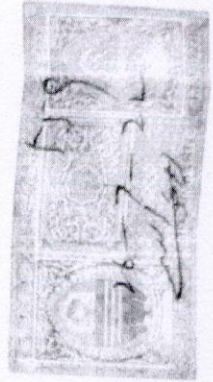
