
Sir/Madam,

In reference to the subject and letters cited above, I am directed to refer to this office letter under reference (i) above (copy enclosed), wherein State Govt. has been requested to furnish certain information raised by Ministry. State Govt. submitted 5 nos. of proposals for exploratory drilling location which has been proposed in Doyang Reserved Forest under Golaghat Division in favour of ONGC which is under process in Sub – office, Guwahati i.e. exploratory drilling location KSAI (2.1 Ha), SPAA (1.731 Ha), TLAB (1.781 Ha), ELAJ (2.2091 Ha), SUAD (1.8212483 Ha).

In view of the above, State Govt. is requested to furnish the list of all exploratory and production drilling proposals applied and granted Forest Clearance under F(C) Act, 1980


