Sir,

With reference to the subject and letter cited above I am directed to inform that the proposal was discussed by REC and forwarded to Ministry for approval of the competent authority. The following information are to be submitted as desired by Ministry:-

1. To provide a cumulative impact study considering the holistic landscape and distance of the nearby mines i.e., the currently under process proposals (i.e., Lankanjuri, Balgenga, etc.) and four numbers of approved proposals ( Bipin Stone Mahal, Modertoli Stone Mahal No.2, Modertoli Stone Mahal No.3 and Modertoli Stone Mahal No.4)
2. State Govt to clarify whether the proposed area falls within no development zone or not?
3. Whether the proposed area is a part of any Eco-Sensitive Zone of nearby protected area or not?
4. State Govt to submit a holistic and comprehensive human elephant conflict management plan for the entire landscape around the proposed area.

State Govt. is requested to furnish the above information to this office at the earliest for further processing of the proposal.
