With reference to the above subject, M/s Wind World (India) Ltd., has submitted a proposal through web portal mode for Renewal of Lease proposal for 106.769 Ha of Forest Land for Wind Power Project in Jogimatti and Marikanive Reserve forest, earlier the same land has been diverted in favor of M/s KREDL for sub lease to M/s Enercon (India) Limited presently Wind World (india) limited on BOT basis for the total area of 221.80 Ha in Chitradurga district for approval under Forest (Conservation) Act, 1980. Accordingly, a communication through online was received to process the said proposal and to submit specific opinion vide ref (1).

The report on this proposal has already been submitted from this office vide reference (2). The Chief Conservator of Forests, Ballari Circle, Ballari vide above reference (3) has directed to furnish the following information/documents required for further processing of the proposal.

1. During the physical examination, though the roads are demarcated by pillars with yellow coloured mark, it was not matching with the area shown on the map with physical measurement on the ground.

- 2. No demarcation was done in the area of Wind Fan Flat form. As per the Chapter 8 of hand book of FC guidelines, the area between the each wind mill should also be taken into account for diversion as corridor between successive wind mills which is not incorporated in the present proposal. The user agency to include this area with proper demarcation on the ground.
- No demarcation was done for the electric transmission lines, the user agency to demarcate with pillars on the ground at an interval of every 100 meters.
- No demarcation was done at Vacuum Circuit Breakers (VCB) sites. The user agency to demarcate these sites on the ground for field verification.
- 5. As, it is to be considered as new diversion though it is a renewal as per the FC guidelines, what is the stand of the user agency on this matter of NPV and CA land and CA charges to be specified in the proposal.

You are therefore requested to submit above information/documents in Eight (8) sets of hard copies for further action in this regard.
