- 5) Deputy Conservator of Forests, Alibag Forest Division, Alibag has not submitted justification of 3 alternative alignment certificate. The copy of the same should be submitted in 3 copies.
- 6) Copis of the 7/12 extract of diverted area in Gut No.216, 13, 37, 90,110,168 & 98 Pt.not enclosed along with proposal.
- 7) Index Map of Talashet, Dalvi Kharoshi, Bopoli, Beloshi and Kune villages not enclosed along with proposal
- ★ 8) Copy of the administrative/technical approval not enclosed along with proposal.
 - 9) The Cross sectional map/ L-Section Map not enclosed along with proposal.
 - 10) The relevant document regarding status showing Private Forest Pending for enquiry not submitted along with proposal.
 - 11) The User Agency not submitted undertaking regarding User Agency shall compensate the private forest land holders as per the prevalent Act.

The above discrepancies should be complied at the earliest.
