8B/RAJ/07/15/2017/FC: Udaipur-Himmatnagar Railway Line Gauge Conversion Project.

The details of the proposals are as under:

1. The Gauge conversion of Udaipur-Himmatnagar railway line from meter gauge to broad gauge is in progress. For this purpose, diversion of track is required to meet the parameters of broad gauge track which requires additional land including 35.7823 ha of forest land.
2. The proposal has been signed and recommended by the all concerned authorities in the part I, II, III, IV & V. In part II, III, IV and V of the proposal, no specific comments have been recorded by the concerned authorities.
3. As per Site inspection reports (on page 139 & 150 of the proposal) and Part II filled by the concerned DCFs having territorial jurisdiction on proposed forest patches- no violation of Forests (Conservation) Act-1980 has been reported.
4. As per part II of the proposal the proposed forest patch is not part of National Park, Wildlife Sanctuary, Biosphere Reserve, Tiger Reserve, Elephant Reserve, Wildlife Migration Corridor etc. and does not fall within eco sensitive zone of the protected area.
5. As per part II of the proposal; the proposed forest patches are not located in the area having protected archaeological / heritage site / defence establishment or any other important monument and no any rare/endangered/unique species of flora and fauna found in the area.
6. The detail of forest area and number of trees (gbh>30cm)/poles (gbh<30cm) is as under-

7. As per part II of the proposal all patches belongs to forest type Eco Class III and vegetation density 0.75 for Udaipur (South) Territorial and Eco Class III and vegetation density 0.4 for Udaipur (North) Territorial
8. Compensatory afforestation has been proposed on equivalent Non-Forest Land (NFL) i.e.35.7823 ha. on single patch having location at Karget, Girwa District- Udaipur. As per GIS-DSS analysis, the proposed compensatory afforestation patch is suitable for plantation.
9. The certificate of District Magistrate under Forest (Rights) Act 2006 is placed with the proposal on pages 57-119 of compliance report.
10. The estimated cost of the project is Rs.82974 lakhs.
11. The detail of the employment generation potential of the proposal is permanent-500 and temporary-50,000.
12. The user agency has submitted undertaking to make payments of Net Present Value (NPV), Compensatory Afforestation (CA) etc. Details of CA and NPV levies are mentioned below in a tubular form:

*Specific recommendation of DCF, Udaipur:*

1. Construction of loose stone wall with estimated cost of Rs.26,65,733/-
2. User agency should plant trees at their cost along proposed railway track passing through forest in three lines in consultation with forest department to reduce pollution and to act as barrier.

The proposal was submitted vide letter no.F14(0)2015/FCA/PCCF/2155 dated 04.07.2017 and EDS was raised due to various shortcomings of the proposal vide letter nos. 8B/RAJ/06/14/2016/FC dated 18.07.2017 and 08.08.2017 which are as follows:

- The .kml files for proposed forest land and CA land have not been submitted and the same have not been uploaded online.
- Geo-reference maps of proposed forest land and CA land have not been submitted.
- Geo-coordinates of proposed forest land as well as CA land and Toposheet in standard scale have not been submitted.
- The submitted FRA, 2006 certificate along Xerox copy without seal of concerned District Magistrate.
- Calculation of NPV submitted with proposal is incorrect.
- Most of the documents/undertaking submitted with proposal are xerox copy and to submit documents/undertakings with name, designation, date and seal of the concerned authority.
- The above issues have been resolved vide State Government's letter no. F14 (Rail)/2016/FCA/PCCF/2366 & 2893 dated 25.07.2017 and 24.08.2017 respectively.
- The State government has been requested to submit consent on transfer of unutilized Forest land ,if any, presently under use for metre gauge railway line vide this office letter no. 8B/RAJ/06/14/2016/FC/240 dated 30.08.2017 and compliance has been submitted vide State Government's letter no. F14 (Rail)/2016/FCA/PCCF/3085 dated 04.09.2017. The user agency has intimated that the Forest land presently under use for Metre Gauge Line shall no longer be required.
