Sir,

With reference to the subject and letter cited above, I am to inform that State Govt letter under reference (iii) above mentioned that "Drilling location NRAA is oil producer and presently in operation and 3 Nos. of tanks are kept there and oil from well is collected in these tanks and then dispatched to Nambar GGS through tankers".

Now in the reply to this office letter under reference (ii) above, para 1, State Govt letter under reference (ii) above informed that the area of mentioned wells is already diverted for exploration. The production/exploitation of hydrocarbon/drilling from the already diverted area is under consideration for policy discussion and ONGC has given an application for land use change for the area diverted during exploratory activities to the State Govt in view of 2019 guideline of Ministry.

State Govt is therefore requested to conduct the site inspection of the drilling location "NRAA" and its production/exploration status and detail report in respect of the ambiguous statement mentioned above is to be furnished to this office for further processing of this proposal.
