Attention of the Forest Divisional Officer, Nizamabad and District Forest Officer, Nizamabad are provided to the references cited.

The GOI vide reference 8th cited (copy enclosed) has requested to clarify the following points as Addl. information / documents / clarification to consider the proposals.

- (a) From the submitted proposals, it is not clear whether the temples namely (1) Sri Vigneswara Sai Datta Mandiram and (2) Sri Laxmi Venkateswara Swamy Devalayam are located inside the RF boundary or outside. The same may kindly be clarified;
- (b) Details such as History of the temple (like construction year), whether these temples existed during the notification of RF, etc needs to be provided.
- (c) As seen from the map that, an existing road is going to the temple. But the present proposals of 18 m width of road is not justifiable. Also the kml file of the road is shown as a block area rather than a linear entity. Hence, comments on the same may be provided in addition to rectifying the kml file and uploading it in the online application.



It is requested to submit the requisite information lattend on top priority basis, for taking further necessary action.
