

Sir,
With reference to your letter on the captioned subject cited above, it is to inform you that, on scrutiny of your proposal & it is noticed that, the proposal submitted by you for forest clearance permission for diversion for construction of Jeypore-Malkangiri New BG Railway Line of East Coast Railway is incomplete. The following documents are necessary required for the purpose.

1. Detailed note on the project. It must include the information regarding the number of villages and number of persons to be benefited from the project including employment generation.
2. Certificate for minimum use of forest land.
3. Undertaking by to bear the cost of compensatory afforestation.
4. Undertaking to pay the Net Present Value (NPV) of the forest land involved.
5. Undertaking to pay the Additional Net Present Value (NPV), if any, of the forest land involved as decided at a later date as per the decision of the Supreme Court.
6. Forest Rights Act, 2006 certificate from concerned Collector.
7. Species-wise and Girth class wise enumeration list and abstract of trees (abstract to be given at the end of the list) standing in the forest & non-forest area duly signed by User Agency, Forest Staffs, Revenue Staffs & OFDC Staffs.
8. Abstract of Tree enumeration list. (No. Of trees in Forest Land/No. Of trees in Private Land/No. of trees in Govt. Non- Forest land/Total).
9. DGPS map, Topo Map, KML, Shape files of CA land.
10. Detailed land scheduled for Compensatory Afforestation.
11. Please furnish the land schedule of both forest and non-forest land involved in the project with Khata No. & Plot No. duly authenticated by Tahasildar according to status as on 25.10.1980 (Hal & Sabik)
12. The Page No. is not mentioned in Checklist properly
13. Status of land has as on 25.10.1980 not been furnished in the proper format a certificate has to be furnished by the concerned Tahasildar in the format prescribed by Chief Secretary Odisha in his Letter No. 4822 dated 12.02.2015 addressed to all Collectors as given below;
Certified that status of total land involved in the project (both forest & non-forest) as given in the table below is as per Government records as 25.10.1980.
