Attention of the Conservator of Forests is invited to the references cited.

Proposal returned for rectification of shortcomings pointed out in Principal Chief Conservator of Forests reference 4th cited has been resubmitted through parivesh portal.

Following rectification has not been carried out in the Part-II of Form-A.

i) For the proposed diversion of 0.90 ha of forest land compensatory afforestation has been proposed for planting of 100 plants in 1.80 ha of forest land in Semakkottai RF.

However, kml file has been uploaded for 4.33 ha of linear stretch of path. Further, CA scheme, Scanned copy of geo-referenced map, Survey of India topo sheet, site suitability certificates have not been uploaded in Part-II of Form-A. Total financial outlay mentioned as Rs. 24,15,963 lakhs as against the CA scheme proposal amount.

Above shortcomings may be rectified in the parivesh portal and resubmit the proposal early.


