महोदय.

उपरोक्त विषयांकित प्रस्ताव पर संदर्भित पत्र के माध्यम से राज्य सरकार द्वारा REC की टिप्पणियों (Observations) की अनुपालना रिपोर्ट प्रस्तुत की गई है जो संतोषजनक नहीं है तथा अभी भी निम्नलिखित किमयां पाई गई है:—

- With reference to observation no-1, State Govt. has submitted only the aerial distances of proposed site
 from the DA site. However, the clarification regarding the difference between the DSS analysis report
 and PCCF (CWLW) report has not been submitted. Therefore, State Govt. may submit the proper and
 complete compliance for the same as per observation of REC.
- 2. With reference to observation no-2, User Agency has submitted that Transmission Line is double circuit line. However, no certificate in this regard has been provided as desired by REC. Therefore, State Govt. may provide the same.
- 3. With reference to observation no-3, the compliance has not been done as desired by REC. Rather, User Agency has requested that the forest area may be calculated as per KML file. However, State govt. has not submitted and matter of "KARAM" has not taken up with Ministry. Therefore The State Govt. should take appropriate action to resort the universally accepted system of land measurement units instead of "KARAM" and Nodal Officer, FCA and User Agency shall take up the matter of "KARAM" with Ministry separately.
- 4. With reference to observation no-5, User Agency has submitted the "Tripartite Agreement for Change of Name" from M/s Bhup Raj to M/s Shiv Ganga Hydel Power Project. However, the necessary correction regarding the name has not been updated in Part-I, Para-A-2. Therefore, the User Agency may the review and rectify the same.
- 5. The name of User Agency has been changed from M/s Bhup Raj to M/s Shiv Ganga Hydel Power Project as per Tripartite Agreement, however in State Government letter, the name of User Agency is still M/s Bhup Raj. Therefore, same may be reviewed and comments with supporting documents may be provided.

I/10540/2022 As per the DSS analysis, 1 ha of area out of 2.5 ha for CA land falls under the Moderately Dense Forests (MDF) category. Therefore Sate Govt. may review the same and revised CA area having density less than 0.4 may be provided, if required.

- (i) The status of proposed CA land may be provided, whether it is a Govt. Waste land declared as UPF under HP Govt. notification, 1952 or is notified as UPF/DPF under IFA, 1927 and is in possession of State Forest department or not.
- (ii) State Govt. may submit document regarding the suitability of land for CA in lieu of forest land proposed for diversion in terms of its vicinity to the area being proposed for DA and/or contiguity with the existing forest area and also ensure the manageability as per the latest Guidelines of MoEF & CC vide letter No. 11-423/2011-FC dated 13.07.2022.
