I wish to inform that the Section 2 proposals for providing B.T. to the road from Nanda-Pagulachennuru at 7/6 km to Kodama village passing through Duggeru R.F., Makkuva Section of Saluru Range have been submitted to the Prl. Chief Conservator of Forests, A.P. Guntur.

The Prl. Chief Conservator of Forests, A.P. Guntur in the reference 7th cited has requested the user agency to submit the C.A. land details for the said road proposals. But the C.A. land details are still awaited from the user agency. However the proposals were uploaded in the Ministry's website (www.parivesh.nic.in) on 08.07.2021 and submitted the hard copies to the Conservator of Forests, Visakhapatnam.

The Conservator of Forests, Visakhapatnam in the reference 9th cited has returned the proposals and requested the user agency to furnish the C.A. land details for further process.

In view of the non receipt of C.A. lands details from the user agency sofar, the (5) sets of proposals are returned herewith to the Executive Engineer, Panchayat Raj, (PIU), Vizianagaram with a request to furnish the C.A. land details in the said road proposal as per the guidelines issued by the Government of India, Ministry of Environment and Forestry and CC, IRO, Vijayawada in F.No.4-APB107/2021-Vij/32, dated: 16.04.2021 and submit to this office for onward submission to Prl. Chief Conservator of Forests, A.P. Guntur through Conservator of Forests, Visakhapatnam at the earliest.
