I wish to inform that the Section 2 proposals for formation of road from Diguvasembi to Thonam road via Dippalapadu of Saluru Range have been submitted to the Prl. Chief Conservator of Forests, A.P. Guntur.

The Prl. Chief Conservator of Forests, A.P. Guntur in the reference 8<sup>th</sup> cited has requested the user agency to submit the C.A. land details for the said road proposals. But the C.A. land details are still awaited from the user agency. However the proposals were uploaded in the Ministry's website ([www.perivesh.nic.in](http://www.perivesh.nic.in)) on 13.07.2021 and submitted the hard copies to the Conservator of Forests, Visakhapatnam.

The Conservator of Forests, Visakhapatnam in the reference 10<sup>th</sup> cited has returned the proposals and requested the user agency to furnish the C.A. land details for further process.
