Kindly refer to the online proposal of Government of Jammu & Kashmir on the abovementioned subject seeking prior approval of the Central Government for diversion of 0.525 ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980

After careful examination of the above-mentioned proposal of the Govt of J&K, the following information/clarification are still required to be submitted:

- UT administration needs to furnish the detail that the proposal is for construction of a (i) new road or widening of an existing, as a road is already in existence that can be seen in the KML of the proposal.
- Since the proposed land passes through notified protected area, hence the NPV (ii) applicable will be five times than the usual NPV amount. Revised NPV sheet to be
- Wildlife clearance from the concerned department is to be submitted. (iii)
- The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want to information.
