In response, the Government of India vide Ref (3) has raised the EDS query and informed that as per Para 11.2 of the Comprehensive Guidelines issued under Forest (Conservation) Act, 1980 vide letter dated 28-03-2019, any proposal for linear

projects such as roads, railway lines, transmission line, etc., needs to be processed in its entirety for comprehensive assessment of requirement of forest land and consequences if approval for any forest land is not granted. Since it has been now reported that 3.323 ha of forest land in Chitradurga district and 3.53 ha of forest land in Davanagere district are also required for completion of the project, the User Agency may be directed to submit a comprehensive proposal including the requirement of forest land in other districts with all mandatory details and to submit the same for consideration under Forest (Conservation) Act, 1980. Copy of the Government of India letter is enclosed herewith.

Therefore, it is therefore requested to submit a comprehensive proposal including the requirement of forest land in other districts also as directed by the Government of India.

The FC web portal link is being transferred herewith to Chief Conservator of Forests, Hassan Circle for further transmission to you through Deputy Conservator of Forests, Tumakuru Division.
