Sub: Proposal for diversion of 0.34 ha. forest land for rehabilitation and up-gradation of Nagpur-Katol-Warud National Highway (NH-353J) from existing Km 60+100 (End of Katol bypass) to 101+085 (Warud up to Joint Junction) to two lane with paved shoulder in Villages-Paradsinga and Bharsingi, Taluka- Katol and Narkhed, District- Nagpur in the state of Maharashtra-regarding.

The Government of India, MoEF & CC, Regional Office, Nagpur vide letter under reference no.1 has sought compliance on 04 points. The compliance of shortcoming has been received vide your letter under reference no.3. However, it is observed that the compliance report of the shortcoming without proper scrutiny has been submitted to this office. The following factors emerge:-

1. Maps viz. 10 Km radius map showing PA's and Village map is not properly submitted. There should be clear indication of Protected Area on the same map along with distance from the proposed forest land.
2. The map enclosed with compliance report is not a Differential GPS map as asked by Regional Office, Nagpur. The Differential GPS map needs to be certified by the Deputy Conservator of Forests (T) concerned.
3. Details of realignment, if any, in forest land and structures proposed in alignment is not submitted. The same needs to be submitted.

4. Details of employment potential in terms of man days of skilled, semiskilled and unskilled persons on permanent (direct and indirect) and temporary (direct and indirect) basis have not been provided. The same needs to be provided.

The above discrepancies need to be complied and submitted alongwith all the required documents in **English** to this office at the earliest for submission to the Ministry for consideration.
