A. Status Report of proposal for diversion of 56.531Ha. of forest land for MSRP Gr.II Package II Phase II Bolia veng to Phairuangkai under Lunglei forest division

- a. Forest Land Area 56.531Ha.
- b. Non Forest land –Area 45.272Ha.
- 1. Hard copy of Proposal first received on 13.6.2018. The project proposal was having details only of RRF and hence the project proponent was requested to provide KML file of entire stretch vide No.G.18015/1/2017/1-DFO(L)/89 dt 19.7.2018 inorder to ascertain the area of Deemed forest to be required for the project.
- 2. Reply received on 12.3.2019 from Project Director, PIU, PWD.
- 3. When Lunglei Range Team went for field verification and tree enumeration, they found it difficult as there is no proper demarcation of the proposed road alignment done on the ground by User Agency.
- 4. Hence some assistance from user agency was requested vide No.G.18015/1/2017/1-DFO(L)/117 dt 28.5.2019.
- 5. PCCF (CAMPA & NO FC) also wrote to PD-PIU, PWD for providing necessary assistance vide his letter No.B.22019/9/2017-FC/PCCF/62 dt 9.7.2019. But reply/response is still awaited from PD-PIU. Hence the processing of Part II is still pending.

B. Status Report of proposal for diversion of 13.8Ha. of forest land for construction of MSRP Gr.II Package I, Phase II (New Khawlek to Bolia veng) road.

Area: Forest land 6.6 Ha under Lunglei Forest division

Since there is no proper demarcation on the extent of land required for the diversion of the project, assistance from project proponent is required for further processing. The request has been made to PD, PIU, PWD but response from them is still awaited. Hence the processing of Part II is still pending.

C. Details of assistance required:

- 1. In the form of Field Surveyors who could guide us on ground on the extent of the area required for road project.
- 2. Chainage wise details of Private land holdings along the entire Stretch of road.
- 3. Chainage wise details of 'RoW' for the entire stretch.
