In the reference 1st cited, an online proposal was uploaded by the Block Development Officer, Pallipattu Panchayat Union, Pallipattu for the diversion of 0.30 Ha. of Reserve Forest land in Kodivalasa Reserved Forest for construction of road in the existing cart track mud road having right of way leading to Udhayavelmurugan Temple in Nillikundram Malai in Pallipattu Taluk of Tiruvallur Forest Division.

In the letter 3rd cited, the District Forest Officer, Tiruvallur Division has submitted his field inspection, recommendation report along with related hard copies.

In the covering letter, the District Forest Officer has mentioned 0.133 Ha. of RF land in Kodivalasa RFs has to be diverted for this project instead of 0.30 Ha. uploaded in the web-portal. Further, he has mentioned 6.0 m. width to the proposed road. The width required for BT surface and width required for brim portion has not

been informed separately. Hence, it is requested that these details may be submitted at the earliest.


Further, as per para 2.5 of special provisions for CA for certain categories of the projects CA shall be raised and maintained at the cost of User Agency on degraded forest land in twice in extent of the forest area to be diverted for the projects. Hence, cost required for raising CA in twice the extent of forest land to be diverted may also be worked out and included in the project proposal.
