Sir,

Referring to the subject mentioned above, I would like to state that the above project proposal involves diversion of forest area of 123.431 ha in total and as stipulated by the Central Government in para 3.2 (i) of the Forest (Conservation) Act -1980, '*Compensatory Afforestation are to be done over equivalent area of non-forest land*' and as per para 3.4 (i) , '*equivalent non-forest land identified for the purpose are to be transferred to the ownership of the State Forest Department and declared as reserved/protected forests, so that the plantation raised can be maintained permanently.*'

In view of the above and as per requirement in filling up of Form - A Part-II, Para- 9 of the Forest Clearance Portal in respect of these projects ,Revenue Department ,Mizoram may be approached from your end for Identification of equivalent non-forest area for transfer and mutation of the non-forest land in favour of the State Forest Department, Mizoram in 4 (four) separate patches as above on area suitable for creation of plantation so that Part-II of the above proposals could be completed early for obtaining Forest Clearance as per relevant provisions.
