With subject and reference cited above, I am directed to inform that the proposal was discussed in the REC meeting held on 31.08.2021. The Committee decided to approve the proposal for issue of Stage-I approval subject to receipt the following information.

- ✓ 1/ As per DSS analysis, out of 90 ha of degraded forest land identified for planting of balance seedlings, 23 ha is VDF/MDF. Hence, the State Govt. has to revisit the degraded forest land and realign the degraded forest land to compensate the 23 ha of VDF/MDF area and submit revised C.A. Scheme along with DGPS map and KML file of degraded forest land for C.A. within 15 days.

It is therefore requested to kindly furnish the above information to this office for further necessary action.
