Subject:- Diversion of 0.3534 ha of forest land for construction of HRTC Bus Stand at Nankhari within the jurisdiction of Rampur Forest Division, Rampur Bsr.

Please refer to the subject cited proposal uploaded in PARVISH portal on 19.9.2023.

2. After going through the online proposal, following shortcomings have been noticed:-

- i) In online Part-I A-I at Sr. No. VII cost of the project has been mentioned as Rs.1000 Lakh whereas, in the hard copy of Part-I Sr. No. 13 the cost of the project has been mentioned for Rs.200 Lakh. This need to be clarified.
- ii) In online Part-I at B- 2.4 no component of dumping has been mentioned. After going through the whole proposal no muck management plan found attached and no forest/non-forest land identified for its disposal of muck.
- iii) In the Checklist No. 10 the details of alternative examined have not been mentioned.
- iv) The uploaded copy of FRA certificate issued by SDO (Civil) Rampur dated 29.2.2020 is not legible. Further the attendance sheet of the FRA proceeding at Gram Panchayat level is also not found uploaded.
- v) In the online Part-I at Sr. No. B 2.4 (component wise requirement of forest land) and other concerned documents the forest land is required for only one component i. e. construction of bus stand. After going through the lay out plan of the proposal at Sr. No. 11 of additional documents the following components have been found mentioned:-

Further all other documents of the proposal find mention requirement of 0.3534 ha of forest land for construction of bus stand whereas, as per layout plan total requirement of forest land 0.3504 ha. This variation in requirement of forest land for construction of forest land needs to be clarified.

vi) In the joint inspection report, 0.3534 ha of forest is recommended for construction of bus stand with shopping complex. Perusal of proposal reveals no such requirement of forest land for construction of shopping complex. This needs to be clarified.

vii) The maximum checklist wise documents uploaded do not bear any date and place.

viii) At Sr. No. 16 of Additional information in the undertaking of payment of additional NPV, the following lines found mentioned which needs to rectified and correct undertaking be uploaded:-

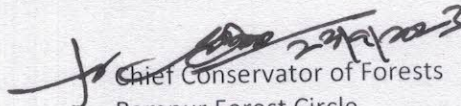
" I hereby undertake to pay additional value of NPV on the above forest land as per prevailing wage rate at the time of plantation."

ix) The enumeration list has not found uploaded.

xii) At Sr. No. 12 of online Part -II yes or no should be mentioned whereas, no data uploaded against this column.

Xiii) In hard copy of Part-II at Sr. 12 (iv) & (v) the data found updated upto 31.3.2022 whereas the same should be updated upto 31.3.2023.

The proposal may please be re-examined keeping in view the above observations and re-submitted to this office for further necessary action.
