भारत सरकार, पर्यावरण वन एवं जलवायु परिवर्तन मंत्रालय नई दिल्ली द्वारा उक्त संदर्भ पृ दिनांक 17.09.2024 से विषयान्तर्गत परियोजना के सम्बन्ध में 10 बिन्दुओं पर जानकारी चाही गई है जिसमें से निम्नलिखित बिन्दुओं पर जानकारी आपके द्वारा उपलब्ध कराई जाना है:-

- i. The State Govt. shall clarify whether the project requires separate Wildlife Management Plan or otherwise. In addition, the status of implementation of the wildlife management plan prepared for Dudhichua maine shall be submitted.
- v. The State Govt. shall submitted the KML file of 360 ha degraded forest land for CA which was then approved against forest diversion proposal of 180 ha.

 - vii. As per DSS analysis (copy enclosed) small part of proposal CA land on NFL is falling in the forest compartment i.e. Range: Sagoni, Block: padari, Division Damoh. The State Govt. shall look into matter and shall ensure that the CA is proposed on Non-Forest land which is suitable and free from all encumbrances.
 - viii. The DGPS Map and Survey of india Toposheet map showing the proposed Non-forest land for CA shall be uploaded online.

The variation in the forest area within the lease has been observed as the total Mine lease of Khadia OCP is 1697.906 ha. out of which 750 ha approved Forest land is in Uttar Pradesh State and remaining 187.623 ha approved Forest land (180 ha forest approved for Khadia & 7.623 ha forest land approved for Bina extension OCP has been proposed to be included in Khadia OCP) is in Madhya Pradesh State and the user agency has submitted instant forest Diversion proposal for 53.142 ha forest land. Hence, total forest land within the lease is found to be 990.765 ha whereas the State Govt. has stated that the total forest, within the lease area is 904.765 ha. This variation needs clarification.
 - iii. The variation in the approved forest land has been noticed in the State Govt. letter dated 05.08.2024 because as per the approved granted by Ministry vide letter no. 8-298/87-FC dated 30.07.1990 for an area of 1305.00 ha which includes 750 ha for Khadia OCP Mine whereas State Govt. mentioned that 664 ha has been approved for Khadia OCP Mine in Uttar Pradesh State. This variation needs clarification.
 - vi. The State Govt. shall submit the Map/KML File showing the mineral transportation routes and the additional requirement of forest land if any.
 - ix. The reason for non-inclusion of forest land under Uttar Pradesh State in the instant lease has not been clarified.
 - x. Based upon the compartment boundaries available on the DSS, the forest land within the lease was found 242.574 ha out of which the State Govt. has given details of 240.765 ha forest land only. Hence, status of 1.809 ha forest land shall be clarified.

I am directed to refer to the APCCF (LM) and Nodal Officer, Government of Madhya Pradesh letter no. F-1/FP/MP/MIN/149270/2021/4171 dated 05.08.2024 on the above cited subject forwarding the required information. The examination of the said information has revealed that:

- i. The State Govt. shall clarify whether the project requires separate Wildlife Management Plan or otherwise. In addition, the status of implementation of the wildlife management plan prepared for Dudhichua mine shall be submitted.
 - ii. The variation in the forest area within the lease has been observed as the total Mine lease of Khadia OCP is 1697.906 ha, out of which 750 ha approved Forest land is in Uttar Pradesh State and remaining 187.623 ha approved Forest land [180 ha forest approved for Khadia & 7.623 ha forest land approved for Bina extension OCP has been proposed to be included in Khadia OCP] is in Madhya Pradesh State and the user agency has submitted instant forest diversion proposal for 53.142 ha forest land. Hence, total forest land within the lease is found to be 990.765 ha whereas the State Govt. has stated that the total forest within the lease area is 904.765 ha. This variation needs clarification.
 - iii. The variation in the approved forest land has been noticed in the State Govt. letter dated 05.08.2024 because as per the approval granted by Ministry vide letter no. 8-298/87-FC dated 30.7.1990 for an area of 1305.00 ha which includes 750 ha for Khadia OCP Mine whereas State Govt. mentioned that 664 ha has been approved for Khadia OCP Mine in Uttar Pradesh State. This variation needs clarification.
 - iv. The State Govt. has not submitted/uploaded the technically approved CA scheme/crop improvement program along with site suitability certificate for

non forest land proposed for CA which needs submission.

- DFD v. The State Govt. shall submit the KML file of 360 ha degraded forest land for CA which was then approved against forest diversion proposal of 180 ha.
- UA vi. The State Govt. shall submit the Map/ KML file showing the mineral transportation routes and the additional requirement of forest land if any.
- DFD Damoh vii. As per DSS analysis (**copy enclosed**), small part of proposed CA land on NFL is falling in the forest compartment boundary i.e. Range: Sagoni, Block: Padari, Division: Damoh. The State Govt. shall look into the matter and shall ensure that the CA is proposed on Non Forest land which is suitable and free from all encumbrances.
- DFD viii. The DGPS Map and Survey of India Toposheet map showing the proposed Non Forest Land for CA shall be uploaded online.
- UA — ix. The reason for non-inclusion of forest land under Uttar Pradesh State in the instant lease has not been clarified.
- UA- x. Based upon the compartment boundaries available on the DSS, the forest land within the lease was found 242.574 ha out of which the State Govt. has given details of 240.765 ha forest land only. Hence, status of 1.809 ha forest land shall be clarified.

The Government of Madhya Pradesh vide their letter No. F-1/FP/MP/MIN/149270/2021/4171 dated 05.08.2024 (uploaded on 07.08.2024 in the PARIVESH) has submit information/documents. In response to vide Ministry letter dated 28.02.2024. The examination of the same through GIS-DSS tool is as under:-

ix	Given the density of 0.5 of the 53.142 ha forest land, number of project affected trees reported as 27342 appears to be have been estimated on lower side as the proposed area is having Very Dense Forest (VDF) & Moderately Dense Forest (MDF) based on DSS analysis. Therefore, same needs to be reconfirmed by the State.	In this regard, the State Govt. has submitted their clarification regarding number of trees in the proposed forest land. 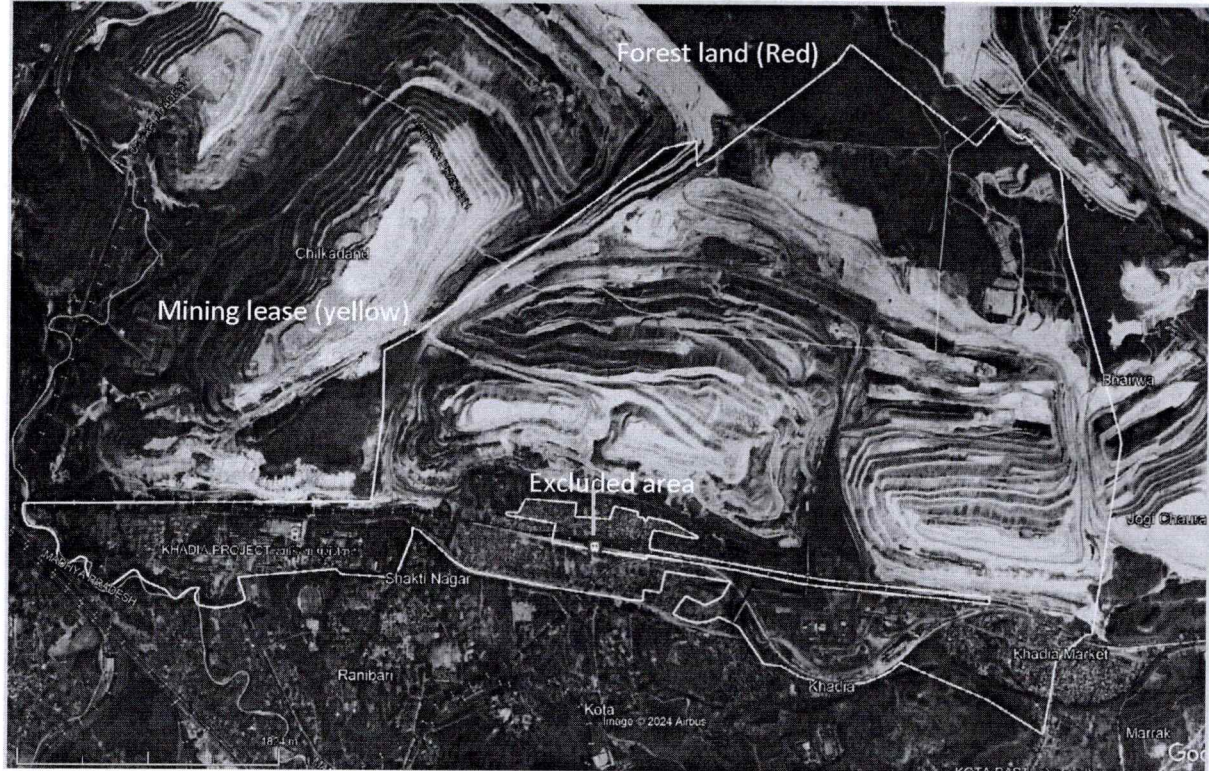

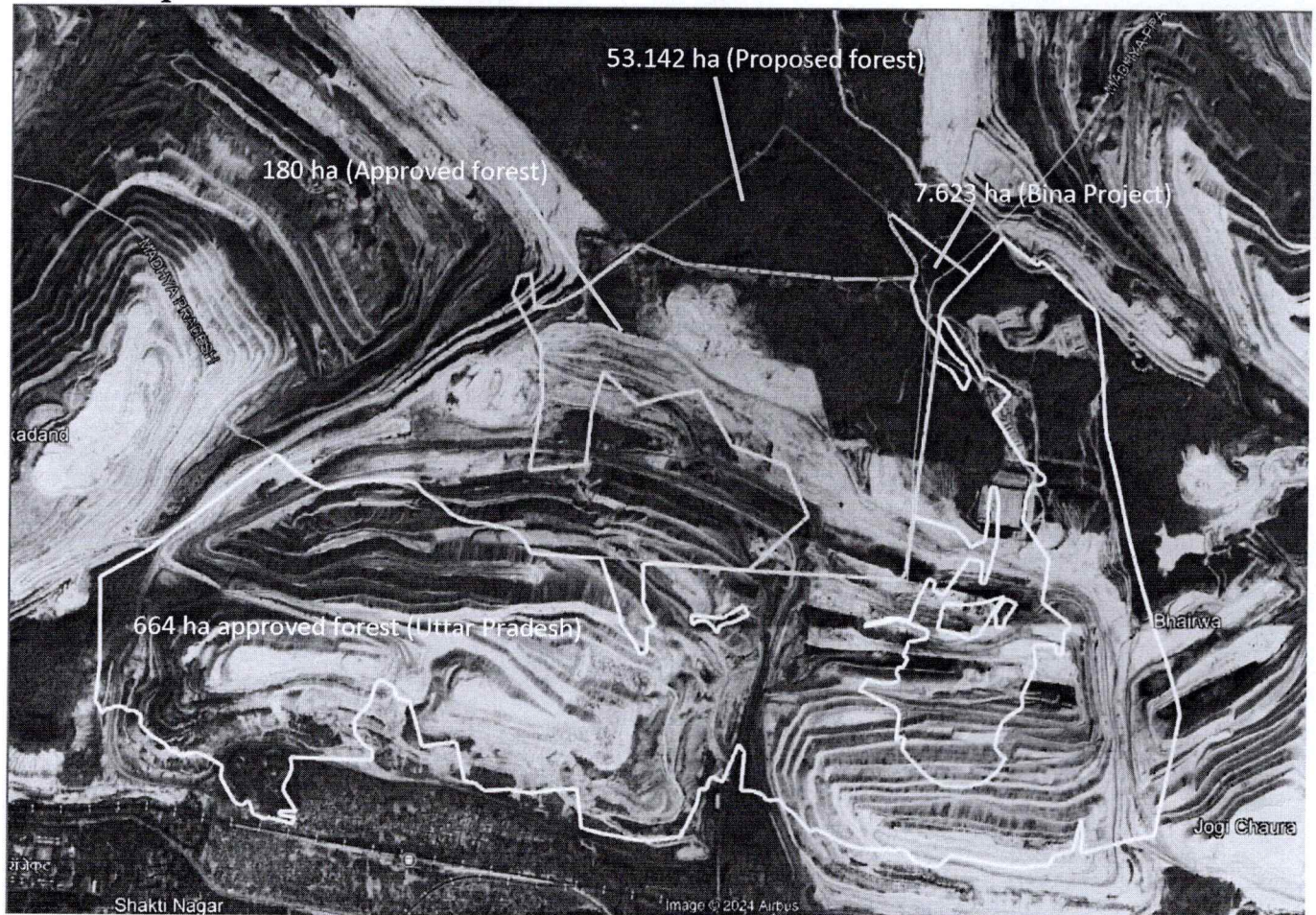
