Revised on-line application furnished by the Block Development Officer, Alangayam, Tirupathur District under Section 2 of Forest (Conservation) Act, 1980 for diversion of 3.439 ha of forest land in Necknamalai Reserved Forests of Tirupathur Forest Division for formation of road from Muniranvattam to Necknamalai to a length of 5.525 km in Tirupathur District has been forwarded for obtaining orders under Forest (Conservation) Act, 1980.

In this regard detailed justification for the following may be furnished immediately.

- i) Diversion of forest has been recommended for a period of 99 years by the District Forest Officer, Tirupathur Division. Justification for the recommendation of diversion period of 99 years may be furnished.

ii) The Additional Principal Chief Conservator of Forests, Vellore Circle has recommended condition that the user agency may be asked to allot funds of about Rs. 20.00 lakhs every year to prevent/ minimize the forest fires, man animal conflicts, providing in situ drinking water to animals to prevent them to go in search of water and to facilitate natural vegetation.


Detailed justification for imposing such condition on the project proposal may be furnished.
