With reference to the above subject matter, M/s Greenko Energies Pvt. Ltd (GEPL) vide Online Proposal No: FP/RJ/HYD/121439/2021 has submitted online application for diversion of forest land of 407.8227 Ha for development of 1800 MW Pumped Storage Project in Baran District, Rajasthan.

In the proposal that 5 times Net Present Value (NPV) has been proposed for the proposed diversion area as the project area falls under conservation reserve. Hence, we represented to the MoEF&CC to clarify applicable NPV in case of conservation reserves. The Ministry has clarified vide its letter no F.
