The following shortcomings have not been noticed which may be attended in all respect:-

1. Though the justification for locating the project has been uploaded in the web portal but hard copies of the same have not been submitted to this office.
2. The demand letter as placed in page No. 5 of the proposal folders is photocopy, original/attested copy may be placed.
3. Page number 25, 26 and 33 to 38 placed in both folder-I are photocopies, and page number 24-27, 33-41, 47-48, 56-59 and 61 onward as placed in folder-II are photocopies whereas, original / authenticated copies of all documents should be placed.
4. It has been revealed that the two numbers of proposal folders without proper page numbering have been submitted. In most of the pages, page numbers have been marked with pencil which is not proper. Besides this, there are lot of differences in the pages as placed in the two folders, whereas, pages in the both folders must be placed in same page numbering.
5. As per the instruction of GoI, IRO Shimla, letter dated 1-9-2021, all authenticated documents of hard copy of the proposal is required to be uploaded in PDF against the additional information details in online Part-I.

You are, therefore, requested to make proper scrutiny of the proposal folders and submit the same after placing all requisite documents either in original or authenticated copies in it. However, the proposal folders are returned herewith for doing the needful.
