महोदय,

उपरोक्त सन्दर्भित पत्र का आशय ग्रहण करते हुए मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरांत निम्नलिखित कमियां पाई गयी हैं:

1. Employment generation details at para E (iii) regarding temporary employment State Govt. provide the employment details in form of number of persons.  
**Action Required:-** State Govt. may upload the temporary employment generation details at para E (iii) in the form of mandays.
2. The State Govt. not uploaded the C/B ratio alongwith the C/B analysis at para G online Part-I.  
**Action Required:-** State Govt. may upload the C/B ratio alongwith the C/B analysis at para G online Part-I.
3. FRA certificate signed by DC is not in prescribed format.  
**Action Required:-** State Govt. may submit the FRA certificate in the formate prescribed by ministry for linear project and upload the same at para K online.
4. The scientific names of the species are not provided in part-ii at para 4 (ii).  
**Action Required:-** State Govt. may provide scientific names at para 4 (ii) in the column local name if not found in the list of species at column scientific name, though in original hard copy the scientific names are provided by the state govt.
5. The approximate distance of the area proposed for diversion from the boundary of forest is not given by the State Government.  
**Action Required:-** State Govt. may submit and upload the certificate regarding distance of the area proposed for diversion from the boundary of forest at para 7 online part-II.
6. The aerial distance of the project site is within 10 Km of Manali WLS.  
**Action Required:-** State Govt. may provide comments of CWLW in view of NBWL guideline dated 08.02.2018 by which the State Govt. have to furnish an animal passage plan, if required by the project proponent on the basis of guidelines issued by Wildlife Institute of India (WII), Dehradun and in consultation of State Chief Wildlife Warden.

7. The DSS analysis of CA area shows that the calculate area comes 9.0 ha in place of proposed 18.0 ha .

**Action Required:-** State Govt. may revise the KML and geo-referenced map of area proposed for CA in two patches and provide correct KML and map for complete 18.0 ha area. The original copy of the revised map may also be submit to this office.

8. The proposal involve felling of 13.55 trees which comes 150 trees/ha. The species of Quercus (Kharsu) maple and Bhojpatra comprise around 50% are ecologically important species though of lower dia category. The concern for the same is also been made by DFO in Part II in the hard copy and the user agency provide an undertaking that felling of 550 trees will be done and rest of the trees will try to save.

**Action Required:-** The State Govt. may reassess the number of trees to be actually felled and to keep this number as minimum as possible and state govt. may also give the comments on the observations of DFO in part-II by some senior official not below the rank of CCF in view of the possibility in reduction of felling involved.
