Kind reference to the above mentioned subject and letter, the proposal was examined at RO, Bhopal and short falls in the proposal. In this connection, I am directed to request you to submit following informations / documents / clarifications:

1. Alternatives explored long with comparative statement duly certified from concerned DFO & Revenue Authorities for the project shall be submitted.
2. A certificate from concerned District Collector stating that no revenue land is available in Gwalior City & District for the said project.
3. A joint certificate from the DFO, Revenue Authority and user agency that no non-forest land (revenue or private) land is available in for the said project.
4. The FRA certificate from concerned District Collector for proposed shall be submitted and uploaded.
5. The Part-II / recommendation of DFO under F(C)A, 1980 shall be uploaded.
6. The Environmental clearance from the competent authority shall be submitted and if Environmental clearance is not applicable, then certificate of same form the competent authority shall be submitted.
7. The details of revenue forest land available in Gwalior city along with maps and KML file shall be submitted.
8. The details of forest land available in Gwalior city along with maps and KML file shall be submitted.
9. Suitability certificate of CA land and detailed breakup of proposed area along with map duly certified from concerned DFO shall be submitted.
10. As per DSS analysis, the proposed area is only 7.42 Km away from Ghatigaon Wildlife Sanctuary, CWLW comments shall be submitted.
11. As per Para 11.1(vii) of FCA Handbook 2019, it is non site specific project.

Thus, justification for the selected land shall be submitted.

12. The action taken on the this office letter no. 6-MPB028/2011-BHO/857 dt. 21/08/2019 (A-I) shall be submitted.

Further, this office had rejected the similar type of two (2) projects (area: 0.99 ha 6-MPB028/2011-BHO & 1.00 ha 6-MPB09/2017-BHO) in nearby same area locality with clear recommendation (copy enclosed A-II/ A-III). Such proposal may kindly be discouraged which can be very well be taken up in Private / Revenue / Non-Forest Land.
