Subject: Diversion of 2.178 hectare of forest land in favour of HPPWD for the construction of link road from Panyala to Tiun Khas Km 0/0 to 5/500 within the jurisdiction of Bilaspur Forest Division.

Sir,

Please refer to your office letter No. PW/GHD/CB/WA/Forest Case/2020/6222-23 dated 6.8.2020 on the subject cited above.

From the perusal of proposal folders, a Fire line/Inspection path has been shown/mentioned as already constructed by Forest Department about 35 years ago having 3.630Km length with 3 to 3.5 mtr width. But as per old and new approved Working plans of this Division, no such fire line is exists. As such this aspect is required to be authenticated with valid documents. Besides this the following shortcomings may please be attended to:-

1. In the proceeding of District Level Committee meeting held on 13.8.2014 (page-34) the area is mentioned 2.157 ha whereas it is 2.178 ha.
2. There is overwriting in area mentioned in FRA Certificate duly issued by DC-cum-Chairman District Level Committee, Distt. Bilaspur, HP which may be got authenticated by the competent authority.
3. The date of online submission of proposal is 1.7.2016 whereas in detailed note it is mentioned as 1.7.2019 which may please be corrected.
4. As per detailed note on project and violation certificate, the total length of road is 0/0 to 5/500 Km out of which 3.630Km road passes through the forest land and rest of the road i.e. 1.870Km passes through private land. Meaning thereby and as evident from page No. 20 & 21 the road from RD 0/0 to 1/870km passes through private land and from RD 1/870 to 5/500Km (3/630Km) passes through forest land whereas as per note on project, the existing track is mentioned upto 3.500Km which needs to be clarified/corrected.

The proposal folders (4 Nos.) received your office memo under reference are returned herewith in original.
