**Subject: Diversion of 2.613 ha of forest land in WLM Eturunagaram division for
Construction of BT Road from Chityal to Bhupathipuram from Km 0/0 to 5/0 in
Kannaigudem Manda! in Mulugu District in favour of Executive Engineer,
Mulugu, R & B Department-reg**


Madam,

With reference to the subject and reference cited above, I am directed to request to submit the following additional documents / clarification etc. at the earliest for further consideration of the proposal under FCA, 1980;

1. Design/cross section of the proposed road clearly indicating the width of carriage way (BT portion), shoulders/Berm/drainage etc. may be furnished.
2. As per rule 6 (3) (c) of Forest Conservation Act, 1980 and FC Rules ,2003 (Amended up to August 2017), the documents, inspection report and part II are to be signed by the DFO concerned. In the instant proposal, it is noticed that Site Inspection Report and Part II are signed by FDO. Hence same may be rectified and resubmit all such documents which are mandatory to be filled / signed by the DFO concerned.
3. The proposed diversion area is falling in Etturnagaram Wildlife Sanctuary area. Hence, Approval / recommendation of SC-NBWL/CWLW and wildlife mitigation measures plan duly approved by the SC NBWL /CWLW may be submitted;
4. Complete kml file of the proposal not been uploaded. Hence correct kml file for the entire stretch proposed for diversion and the DGPS map may be furnished.
5. Legal status of the existing Cart Road/pakka road may be informed along with the supporting documents.
6. As per topo map, Identified Non-Forest area for CA is overlapping with Jally III RF. State government may re-verify and inform whether the NFL identified is a non-forest land or it has some overlapping with the RF area and mutation certificate in respect of NFL shall be furnished.

7. DFL map duly signed by the DFO along with kml file in soft copy be submitted.
8. Some of the components like Vehicle procurement and engagement of computer operator have been proposed in the CA scheme, which is not in consonance with the provisions of CAF Act/ Rules. Hence the same may be revised and submitted.
9. The FDO reported that small and big streams are present. Hence, suitable SMC plan may be prepared in case the proposed diversion has any adverse impacts on the hydrology of the location.
10. The DFO/FDO concerned shall ensure that no work in violation of FCA, 1980 is done in the proposed forest area till a decision is taken by the central government.
