Sub:- Proposal for diversion of 1.973 ha forest land for construction of Re-rolling Plant for manufacturing of TMT bars/rounds ingots/billets of 30000 tons for annum capacity by M/s. Karma Re-rollers Pvt. Ltd, Kapursingh, Pihura.

Ref:- Your Memo No.4391 dated 21.08.2019.

On scrutiny of the above forest diversion proposal the following discrepancies/deficiencies have been noticed which may be complied with immediately.

1. As per check list Sl. No. 3, the Form 'A' Part-I in old format has not been furnished.
2. Check list Sl.No. 11 & 12 has not been signed by you.
3. Certificate for minimum use of forest land has not been signed by you.
4. Undertaking for payment of Additional payment of NPV has not been signed by you.
5. Undertaking to submit the model certificate has not been countersigned by you.
6. The Topo Map showing the forest area proposed for diversion has not been signed the User Agency as well as by you.
7. Topo Map showing the non-forest area for raising compensatory Afforestation has not been signed by the User Agency as well as by you.
8. Check list furnished in the proposal has not been signed by you.
9. The CA scheme has not been prepared basing on the cost norm communicated by the PCCF, Odisha vide Memo No.1335 dated 18.12.2018.
10. In the CA scheme, the wage rate has been calculated @ Rs. 200/- per man-day which needs to be revised in the current wage rate of Rs.286.30 per man-day .
11. The documents should be enclosed in the proposal properly.
12. The identified non-forest land for raising Compensatory Afforestation shown in the Topo Map , it is noticed that the non-forest land has been shown inside Belparha RF though you have reported the land adjacent to the RF. which may be clarified.

In view of the above, the Forest Diversion Proposal received vide your memo under reference is returned herewith in **5 sets** for necessary compliance and resubmission at the earliest.
