With reference to the above mention subject and letter under reference, the proposal was examined at RO, Bhopal. In this connection, I am directed to request you to submit following information/ documents :-

1. The proposal received F(C)A, 1980 clearance vide Letter no. 8C/5/293/95-FC dt. 19/06/1995 and renewal vide letter no. 8C/32/2003-FCW/4373 dt. 26/01/2007. The Complete compliance report of both this clearance is required.
2. The F(C)A, 1980 clearance vide Letter no. 8C/5/293/95-FC dt. 19/06/1995 in the condition no. ii) “CA shall be taken up by the Forest Department in identified non-forest area at the project cost”.
  - a. The non-forest area details shall be submitted along with the map, KML file & details of mutation and forest compartment No.
  - b. The amount deposited in the CAMPA fund for CA and amount utilized for plantation till date shall be submitted.
  - c. The plantation (plants per ha) prescribed in the CA scheme during approval of project, the plantation (plants per ha) planted during plantation along with year of the plantation and present survival % along with number of plants per ha remain as on date.
  - d. The site photographs of the CA plantation.
3. The Approved mining plan & reclamation plan duly certified by competent authority shall be submitted.
4. The FRA certificate & proceedings of Gramsabha shall be submitted.
5. The details of extraction of minerals and royalty paid to Govt. shall be submitted.
6. The material reserved as per approved mining plan in 2007 approval and remaining material reserved in the proposed forest land as on date duly certified by competent authority shall be submitted.
7. The mining area is about 1.00 km away from the nearest road / forest boundary and approach road of mining area is required
  - a. The road / approach road used by the U.A. till date.
  - b. The detailed of area required for the approach road along with KML file.
8. The complete Site Inspection report shall be uploaded on webportal.
