Please refer to your office letter No.D.III.163/3367 dated 07.09.2019 on the subject cited above.

The proposal received vide communication under reference has been scrutinized and found incomplete to the following extent:-

- 1. The density of vegetation mentioned against column No.7 (vi) may be reviewed and correct density of vegetation be mentioned in the proposal folder. Accordingly, part-II be uploaded online against additional document details.
- 2. Against column No.B-2.3, although village wise breakup has been mentioned but as per GoI instructions dated 01.08.2019 which have already been sent vide this office endst. No.D.86 (A).Vol.VII/4064-67 dated 03.09.2019, a certificate (providing detail of villages benefitted) on the prescribed format duly authenticated by competent revenue authority be placed in each proposal folder.
- 3. As per DFO WL Kullu certificate placed at page-131, the distance of Kanawar Wildlife Sanctuary from the project site has been mentioned as 6.0 Km. Therefore, the necessary comments of State Chief Wild Life Warden may be obtained and provided to this office.
- 4. The FRA and other documents placed in the proposal folder has been self attested by the U/A. In this regard, it is to inform you that the documents placed in the proposal folder in duplicate/ photocopies are required to be placed in original or to be attested by the competent/ issuing authority.
- 5. The enumeration list of trees placed in the proposal folder is required to be signed by the DFO.

- The details of temporary employment mentioned online against column No.E (iii) is 150 (person days) which is not in accordance with the details provided in part-I of the proposal folder.
- 7. At page No.8 of the proposal folder, a copy of letter to Sub-Divisional Officer (C) Kullu, H.P. has been placed. Although, the copy of sanction of project from the competent authority has been uploaded online against additional document details but the copy of the same has not been placed in the proposal folder.
- 8. The date and placed has not been mentioned in part-I of the proposal folder.
- The necessary undertakings viz. geo-referenced forest boundary, not to establish labour camps, use of cooking gas/ kerosene oil etc. has not been placed in the proposal folder.

Therefore, you are requested to submit the proposal to this office after properly scrutinizing it in hard shape as well as through online. Submission of incomplete case invites unnecessary correspondence and delay which should be avoided in future. The three proposal folders received vide communication under reference are returned herewith in original for doing the needful.
