Sub: Diversion of forest land (4.309 ha) for non- forestry purpose under Forest Conservation Act, 1980 proposed for Govt. Polytechnic Building for skill upgradation -reg.

Sir,

Kindly refer the letter no. F-5-22/2019/10-2 dated 08.07.2021 of the Government of Chhattisgarh on the above subject seeking approval of the Central Government under Section-2 of the Forest (Conservation) Act, 1980. It is to inform that preliminary scrutiny of the proposal in the Integrated Regional Office, MoEF&CC revealed the following:

- i. Name of signing authorities has not been mentioned in Part-I.
- ii. Part-IV is not submitted in original.
- iii. Examination of compliance of Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006, revealed that certificate issued by District Collector is not submitted in original.
- iv. User Agency has not been mentioned the District Level Committee consultations/proceedings along with proposal.
- v. Details of employment potential in terms of man days of skilled, semiskilled and unskilled persons on permanent (direct and indirect) and temporary (direct and indirect) basis have not been provided.

In view of the above, it is requested to submit the information on the shortcomings, indicated above, for consideration of the proposal for approval under the Forest (Conservation) Act, 1980.
