The Divisional Forest Officer Wildlife Management Division, Tirupati has submitted the proposals for Diversion of 594.75 Ha. of Forest land in Karakambadi RF, Krishnapuram RF of WLM Division, Tirupati for Sri Balaji Reservoir, Mallemadugu Reservoir and Mallemadugu Reservoir vide reference 16th cited.

On scrutiny of the proposals, the Divisional Forest Officer, Tirupati has informed that, the proposed Sri Balaji Reservoir and Mallemadugu Reservoir is not falling in National Park / Wildlife Sanctuary / Tiger Corridor / Elephant Reserve etc., but falls within Eco-Sensitive Zone area of Sri Venkateswara Wildlife Sanctuary, but the extent falls in ESZ in S.V. Wildlife Sanctuary not reported. It is essential as per checklist information.

Hence, the Divisional Forest Officer, Tirupati is requested to submit compartment wise, beat wise area falls in ESZ and RF in tabular column to this office urgently, to process the proposals.
