With regard to the proposal submitted by this office vide Ref (1) seeking Stage-I approval under the Forest (Conservation) Act, 1980 to the Government of Karnataka, the Government of India vide Ref (2) letter dated 29-05-2024 has raised the EDS Query (enclosed) EDS Query are as below and the same was communicated to this office vide Ref (2) letter dated 08-07-2024 by Government of Karnataka.

1. The name of the user agency has been changed from M/s Aarees Iron and Steel limited to M/s Baldota Steel Limited Hosapete. Therefore, necessary changes in PART-1 of the proposal shall be made.
2. The number of trees required to be felled in the revised alignment i.e. in alternative-II has not clearly mentioned. Therefore, it is requested to clarify the number of trees required to be felled in proposed alignment.
3. In the revised alignment, (i.e. in alternate-II), it is proposed to draw the transmission line from existing 33KV sub-station. It is, therefore, requested to clarify the status of the existing 33KV Sub Station. i.e. whether the existing sub-station is in forest land or non-forest land,

approval under Adhiniyam 1980 has been taken for the said substation or otherwise may be clarified.

4. The area proposed for diversion in FRA compliance certificate has been mentioned 1.84 ha instead of 1.74. Therefore, it requested to comment on the same.

Hence, you are directed to communicate to the above points to User Agency through concerned jurisdictional Deputy Conservator of Forests regarding furnishing the needful documents sought by the Government of India at earliest to this office for further processing of the proposal.
