Attention of the Additional Principal Chief Conservator of Forests is invited
to the references cited. The proposal furnished by the Block Development Officer,
Alangayam, Vellore District for diversion of 3.439 ha of forest land in
Necknamalai Reserved Forests of Tirupathur Forest Division for formation of road
from Muniranvattam to Necknamalai length of 5.525 km in Tirupathur District has
been forwarded with the recommendation of the Additional Principal Chief
Conservator of Forests and District Forest Officer, Tirupathur Division.

In the Part-II of the proposal, the following shortcomings noticed.

- i) Detailed CA scheme along with site suitability certificate for the identified
non-forest CA land has not been uploaded in the project proposal. The District
Forest Officer may be instructed to formulate the CA scheme based on the
guidelines issued by the Government of India in letter F. No.11-423/2011-FC.

dated 08.11.2017 and Hand book of Forest Conservation Act, 1980 issued by the Government of India in letter No. 5-2/2017-FC dated 28.03.2019 and upload the same in the project proposal.

ii) In the additional information details section, CA land has been marked in two bits in the Survey of India topo sheet as against the uploading of details in one bit under Sl. No. 13 iii.

iii) Similarly Google map of identified CA land marked in Google map-Geo-referenced map has been uploaded in two bits as against the uploading of details in one bit under Sl. No. 13.ii

iv) The District Forest Officer has not reported justification for acceptance of area already handed over to Forest Department in SF No. 416/1 with an extent of 51.83 ha as per G.O. (D) No. 351, Revenue Department dated 09.08.2002 and already notified under Section 4 of Tamil Nadu Forest Act 1882 vide G.O. Ms No. 79, E&F (FR.14) Dept dated 23.06.2017 as compensatory land for the project proposal.

Above defects may be rectified immediately and re-submit the proposal through online and furnish hard copy of Part I, Part-II&III along with all documents uploaded I the web portal in triplicate copy urgently.


