(For the forest land to be diverted under FCA)**


- 5.1 A Proposal has been received by this office from NIRMAN KHAND P.W.D. CHINYLISAUR UTTARKASHI for diversion under FCA-(1980) of 1.5225 ha. of forest land for non-forestry purpose. The project envisages the use of forest land of construction of CHINYALISAUR-JOGATH MOTOR ROAD TO GORUN MOTOR ROAD. The site inspection of the land involved in the proposal has been done by me on dated.....27-08-20.....
- 5.2 On inspection of the site, it is found that the land required by the user agency is a RF/PF/un-classed/Other forests measuring 1.5225 ha R.F. DICHALI COMPARTMENT No-08 & CIVIL SOYAM LAND.
