महोदय,

उपरोक्त विषय पर ध्यानपूर्वक विचार करने के उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि राज्य सरकार निम्न बिन्दुओं पर आवश्यक सूचनायें प्रेषित करने का कष्ट करें। ताकि अग्रिम कार्यवाही सुनिश्चित की जा सके:-

1. Some other document uploaded in place of alternative examined at para D(ii)a online Part I.
Action Required:- State Govt. may review and upload the correct documents.
2. In VLC proceedings of village Bainjwari, name of village Nakheri mentioned in last para. Also VLC of village Poth not submitted.
Action Required:- State Govt. may clarify the same and submit the original hard copy of VLC meeting proceeding for village 'Poth'.
3. As per DSS report, area calculation of CA proposed is 6.40 ha instead of 3.745 ha.
Action Required:- The State Govt. may upload revise KML file and digital map of CA area.
4. CA area name mentioned in Part II para 13 is Bainjwari, Thati however in CA scheme it is mentioned Kothar (dagar).
Action Required: The State Govt. may clarify the same
5. NPV calculation sheet submitted in hard copy is incorrect.
Action Required: State Govt. may submit the correct hard copy of NPV calculation sheet.
6. The number of trees affected are mentioned as 70 in hard copy, where as it is mentioned as 69 as per enumeration list uploaded in part-II.
Action Required:-State Govt. may correct the discrepancy of number of trees in online portal at para-4 (ii) Part-II and submit in the hard copy.
7. Four sites mentioned for muck dumping in muck dumping plan but same is not mentioned at para B 2.4 online Part I.
Action Required:- State Govt. may mention the 'component muck dumping' details at para B 2.4 online Part I.
