Sir,

With reference to the subject and letter cited above, I am to inform that the additional information along with the DPR submitted by the State Govt vide letter dated 19.06.2019 in respect to this instant proposal has been further examined and found that the the total construction area (expected during the 10 years period in 2 Phases of 5 years each) shows the total area is 0.92 Million Sq ft. which is approximately 8.5 ha. Therefore the Satte Govt is requested to submit the following details to this office for taking further necessary action:-

- 1) The State Govt is to clarify this difference in the area involved i.e 4.5 ha as per the proposal submitted or 8.4 ha as per the Lay-out Plan in the DPR.
- 2) The justification furnished by the user agency vide letter dated 11.12.2018 may be elaborated by the PCCF in terms of
  - (a) site specific need of this project;
  - (b) efforts made for alternative site and how the people will became landless in terms of Government policies;
  - (c) is there no revenue land available? and
  - (d) is there any M.o.U by the user agency with State Govt to establish the university on this particular area?
