- 3. The lay out map of the proposed sub-station with the proposed components.
- 4. The undertaking by the user agency for payment for extraction charges of the trees to be removed from the propose area.
- 5. The proposal name should be specifically mentioned in the recommendation Part IV and V form of Nodal Officer (FCA) and State Govt.

State Govt is therefore requested to kindly furnish the above lacking information to this office for further processing of this proposal.
