Sir,

Kindly refer to the above mentioned proposal received on the PARIVESH Portal at the level of the North Forest Division.. After the scrutiny of the Part-I uploaded by your good self and site inspection of the site proposed for Compensatory afforestation & project area, some discrepancies have been observed which need to be clarified by the DMRC.

Now in order to process your proposal from the North Forest Division, you are hereby requested to submit the following details / documents at earliest:

1. The Deemed Forest area proposed for diversion needs to be updated as there are additional areas which have to be added in the Forest area proposed for diversion.
2. Kml. File of the whole alignment (layout plan of the project site) involved in the proposal.
3. Enumeration list of trees (girth wise & species wise) and abstract of trees, proposed for felling within Deemed Forest/Protected Forests.
4. List of trees already submitted for permission for removal for the above project under DPTA.
5. Detailed Muck disposal scheme is not attached/uploaded.
6. Undertaking by the User Agency to pay the Net Present Value (NPV) of the Forest land involved in the proposal.
7. Statement showing the details of Forest area involved and item-wise break up of Forest Area proposed for diversion.
8. Statement showing the details of Non-Forest area involved in the proposal.
9. Undertaking by the User Agency to bear the cost of Compensatory Afforestation.
10. Certificate for minimum use of Forest Land to be submitted by the User Agency.

11. The User Agency should submit an undertaking to the effect that encumbrance & encroachment free land will be handed over to Forest Department for carrying out compensatory Afforestation. Undertaking from the land owing agency.
12. Statement showing the details of Compensatory Afforestation land (i.e. Survey No./Compartment No. etc.,).
13. Topo sheet/GSDL Map of the land proposed for Compensatory Afforestation along with Geo-coordinates.
14. At least 05 set of complete documents of the above mentioned project, with all the mandatory signed undertakings for the perusal of the undersigned.

You are requested to provide details mentioned above for timely processing of the proposal. It is pertinent to mention that the matter of Forest land proposed for Diversion in the above mentioned project, is still pending before the Hon'ble Supreme Court of India in the matter CEC report no. 11 of 2021 in application no. 1556 of 2021 in W.P.(C) No. 202 of 1995 filed by Dr. P.C. Prasad and Adiya Prasad Petitioners. Therefore, the above mentioned proposal shall be processed after the order of Hon'ble Supreme Court of India.
