विषय : Diversion of 3.6593 ha of forest land in favour of Municipal Corporation Shimla for the construction of Shimla Passenger Ropeway Project, within the jurisdiction of Shimla (Urban) Forest Division, Distt. Shimla, H.P. (online no. FP/HP/Others/32176/2018)

महोदय,

उपरोक्त सन्दर्भित पत्र का आशय ग्रहण करते हुए मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरान्त निम्नलिखित कमियां पाई गयी हैं:

1. The category of the project is mentioned as 'Others' while ropeway projects fall under linear category.

Action Required:- The State Govt. may correct the category of the project as a linear project and make necessary corrections in online part I & II.

2. Administrative approval is not submitted by the State Govt.

Action Required:- The State Govt. may submit upload the Administrative Approval.

3. Scientific names of trees for tree enumeration are not uploaded at part-II.

Action Required:- The State Govt. may upload the scientific names of trees at Part-II 4 (ii) online.

4. A large number of deodar and oak trees are affected by the project that may be taken care of by the Hon'ble NGT order dated 31.08.2017 whereby the State govt has identified 18 ha of plantation site nearby the project area. However as per DSS analysis 2 ha is found under VDF and 12 ha under MDF.

Action Required:- The State Govt may identify double the degraded forest land (i.e. 7.32 ha) for CA area and submit CA scheme with KML file and digital map separately. This is in addition to the plan site proposed

5. NPV calculation is for 'dense forest' which needs to be reviewed (enumeration list of trees i.e. 372 trees ha)

Action Required:- State Govt. may revise & submit the NPV accordingly

6. Working Plan prescription seems to be incorrect.

Action Required:- The State Govt may correct the Working Plan prescription online in Part II para 5 online.

7. Reclamation Plan for muck dumping site is not submitted by the State Govt.

Action required:- State Govt. may submit the Reclamation Plan for muck dumping site.

8. VLC Proceedings submitted do not match with the name of villages affected in B 2.3 Part I.
Action required:-State Govt. may review and correct the VLC Proceedings matching with the name of villages affected in B 2.3 Part I online.

9. As per the record, it is not clear how many trees would be retained/ cut.
Action required:-State Govt. may rectify/ clarify how many trees would be retained/ cut.


