I invite attention to the reference 1st cited wherein the Executive Engineer, (PIU), Paderu has submitted proposal for formation of road under Section 2 of F.C. Act, 1980 from Gummakota to Galipadu village, Ananthagari mandal passing through Chippapalli Forest block of Andra section, Vizianagaram Range/Division.

In this connection, Field inspection was conducted by the undersigned with the Dy. Executive Engineer, Assistant Executive Engineer, Panchayat Raj, Paderu and Forest Range Officer, Vizianagaram on 26.07.2022 for the proposed road from Gummakota to Galipadu of Ananthagiri Mandal. During field inspection it was noticed that the area where Reserved Forest and outside Reserved Forest are meeting it was noticed that there was work executed outside the Reserve Forest which is in continuity to the existing proposal, however certain portion of the area is falling within the R.F. area.

Hence, it is requested the Executive Engineer, Panchayat Raj, (PIU), Paderu to submit specific remarks on the subject matter and lapses to this office and why it cannot be considered as the violation of the Forest Conservation Act, 1980 at the earliest for taking further action.
